When deciding to file a Petition for an E2 Work Visa, it's important to be Aware of the Key E2 Visa Requirements for Investors and Individual Guidelines. The US Citizenship and Immigration Services defines an E-2 Investment as "The Investor's Placing Of Capital, Including Funds And Other Assets, At Risk In The Commercial Sense With The Objective Of Generating A Profit. Your Investment May Be For The Purpose Of Establishing A New Business Venture, Or Purchasing A Pre-Existing Business"[7]. An E2 Treaty Investor Visa is a Non-Immigrant Visa reserved for Foreign Entrepreneurs of Countries that have a Treaty of Trade and Commerce with the United States. E2 Investor Visas allows Foreign Investors to enter and work inside of the United States based on a Substantial Investment in a Bona Fide Enterprise (A Real, Active Commercial Or Entrepreneurial Undertaking Which Produces Services Or Goods For Profit"[7]).

The United States has a Lucrative and Open Consumer Market, as well as Access via Free Trade Agreements to about 425 million more Customers for Goods and Services that are produced in the United States. Treaty Trader (E-1) and Treaty Investor (E-2) Visas are for Citizens of Countries with which the United States maintains Treaties of Commerce and Navigation, including France. You must be coming to the United States to engage in Substantial Trade, including Trade in Services or Technology, in Qualifying Activities, principally between the United States and the Treaty Country ; develop and direct the Operations of an Enterprise in which you have invested a Substantial Amount of Capital ; or fill an Executive/Supervisory Role or provide Skills Essential to the Operations of a Firm that qualifies as an E-1 or E-2 Business.

- How To Apply :

- \* Complete a Specific Form provided by Local Embassy.
- \* Create a User Account and Pay the Visa Fee and Schedule a Consular Appointment Interview.
- \* Within Two Days after Scheduling the Consular Appointment Interview, submit Supporting Documents to the Embassy by email.
- \* Appear for your Interview at the Embassy and hand carry the Complete E visa Application Package (required to Speak English).
- \* If issued, the Embassy will keep your Passport during Processing and will deliver your Passport, Visa, and Documents to you using the Method you selected when you registered for the Visa Appointment.

- On April 19, 2018 at Hôtel Georges V (Paris) was held a Conference on "E-2 Investor Visa" to the United States, given by Immigration Attorney Marcelle POIRIER who came to Paris specially to inform Potential French Investors on the Formalites and Conditions required by the United States Authorities. The Law Firm of Marcel Poirier is based in Miami and has also Offices in Paris and Montreal. Last year, only 22 French Citizen applied and got the E-2 Investor Visa.
